## **TERMS & CONDITIONS**

1. Cancellation of this Contract shall be as follows;
  - a) More than 30 days from the performance date; No fee payable.
  - b) Between 22-30 days from the performance date; 25% of the full fee.
  - c) Between 15-21 days from the performance date; 50% of the full fee.
  - d) Between 8-14 days from the performance date; 75% of the full fee.
  - e) Between 1-7 days from the performance date; The full fee will be payable.
2. Except where specified otherwise, the artiste/s agrees that the fee is inclusive of all expenses, travelling expenses to and from the venue and covers any payments whatsoever due to other members of the band or unit.
3. The artiste/s warrants that all equipment is in good working order, and fit for its purpose, and that no part of the performance is likely to be a danger to the artiste/s or any other person/s.
4. The adjustment of the volume and sound level of any equipment shall be as the client reasonably requires.
5. The artiste/s at the time of signing this contract shall not be under any contract to a third party that might preclude him/her from fulfilling the engagement.
6. All artiste/s are responsible for their own TAX & N.I.contributions.
7. The client shall be responsible for the provision of mains electricity in the performing area.
8. Any deposits paid are non-refundable.
9. This contract reflecting the terms and conditions as verbally agreed shall be deemed accepted only when either;
  - a) It is signed and returned in 7 days.
  - b) It is not exchanged within the prescribed 7 days and no written objection has been made within its period.
